Bids are being taken for the new football field and next year the two baseball fields will go out to bid. There will be water and electricity provided to the Amphitheater and football fields.

Item #5. Discuss the exercise equipment placed at Hewitt Park. New exercise equipment replaced the old exercise equipment and was placed by the basketball court. A cement pad and walk way was added for easy access.

Item #6. Discuss future plans of Hewitt and Warren Park. There will be 4 food truck pads at Warren Park to be located between the Amphitheatre and the Pavilion. Water and electricity will be provided. At Hewitt Park, Dogs Day of Summer will be on June 19, 2015 and it is anticipated to have 5,000 in attendance.
