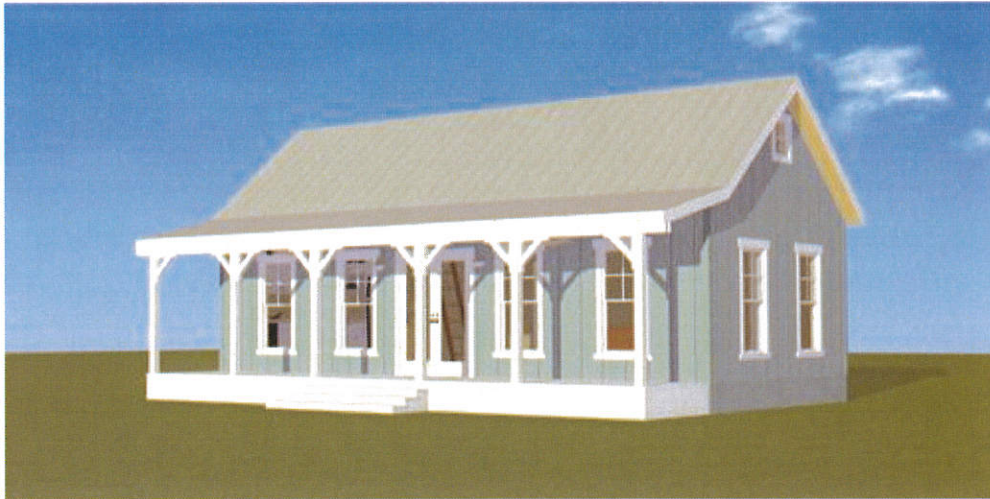

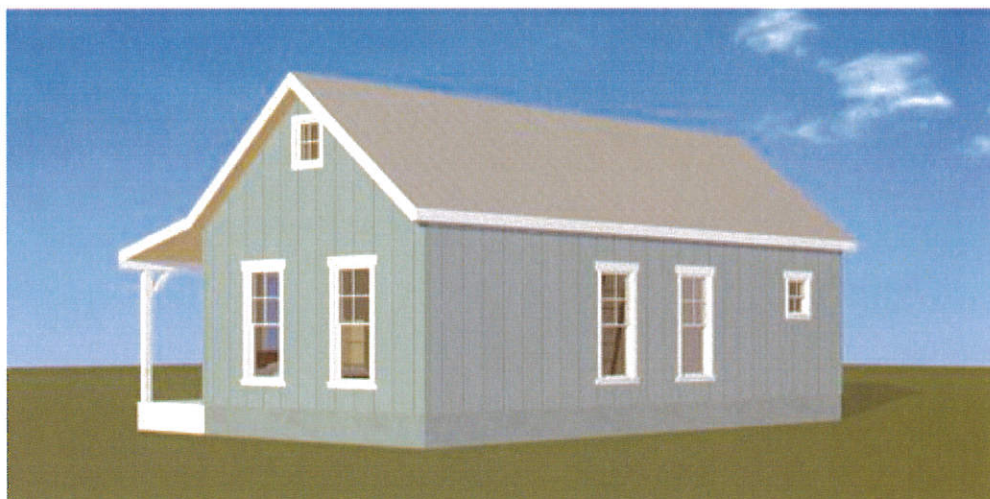
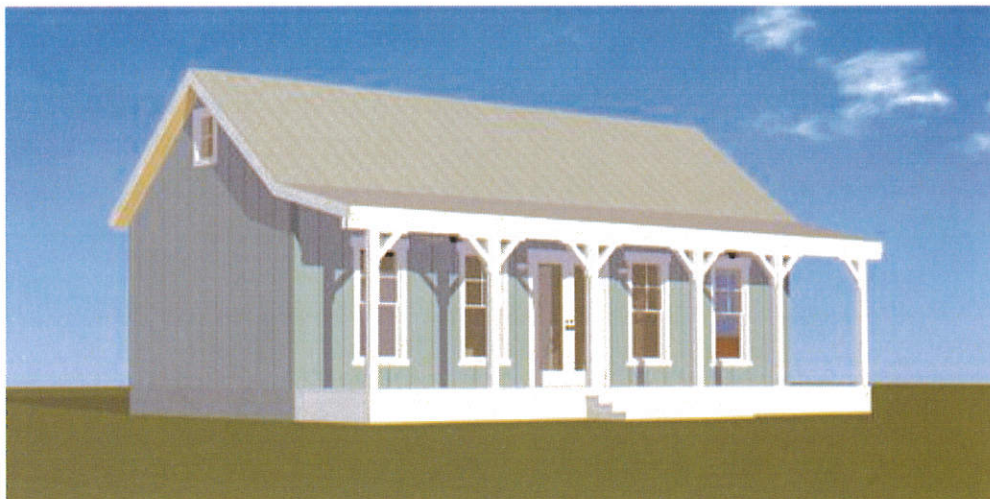

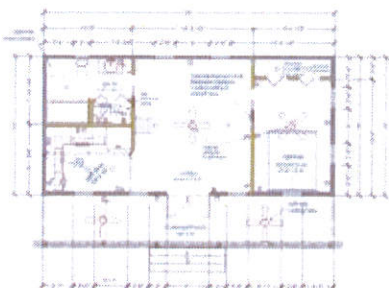
KANGA example (floor plan and virtual view).

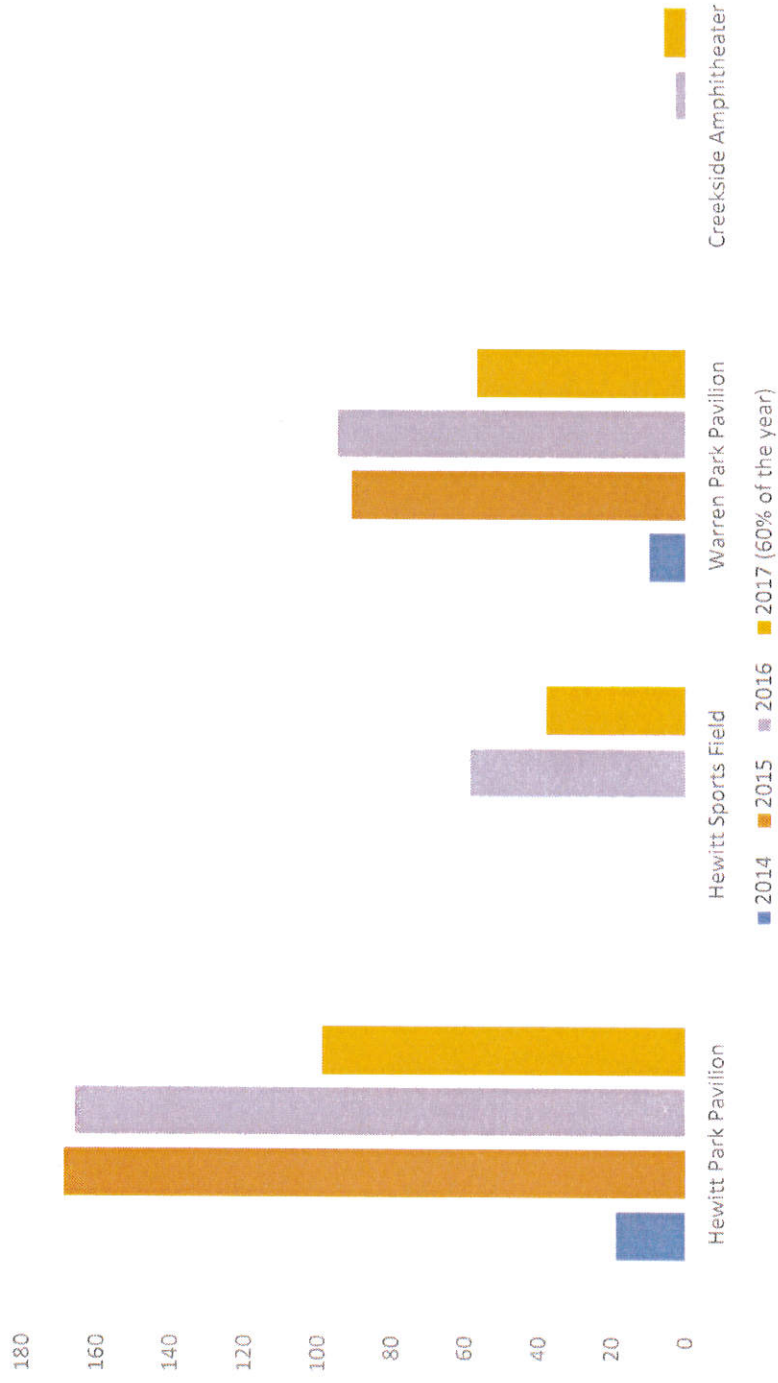

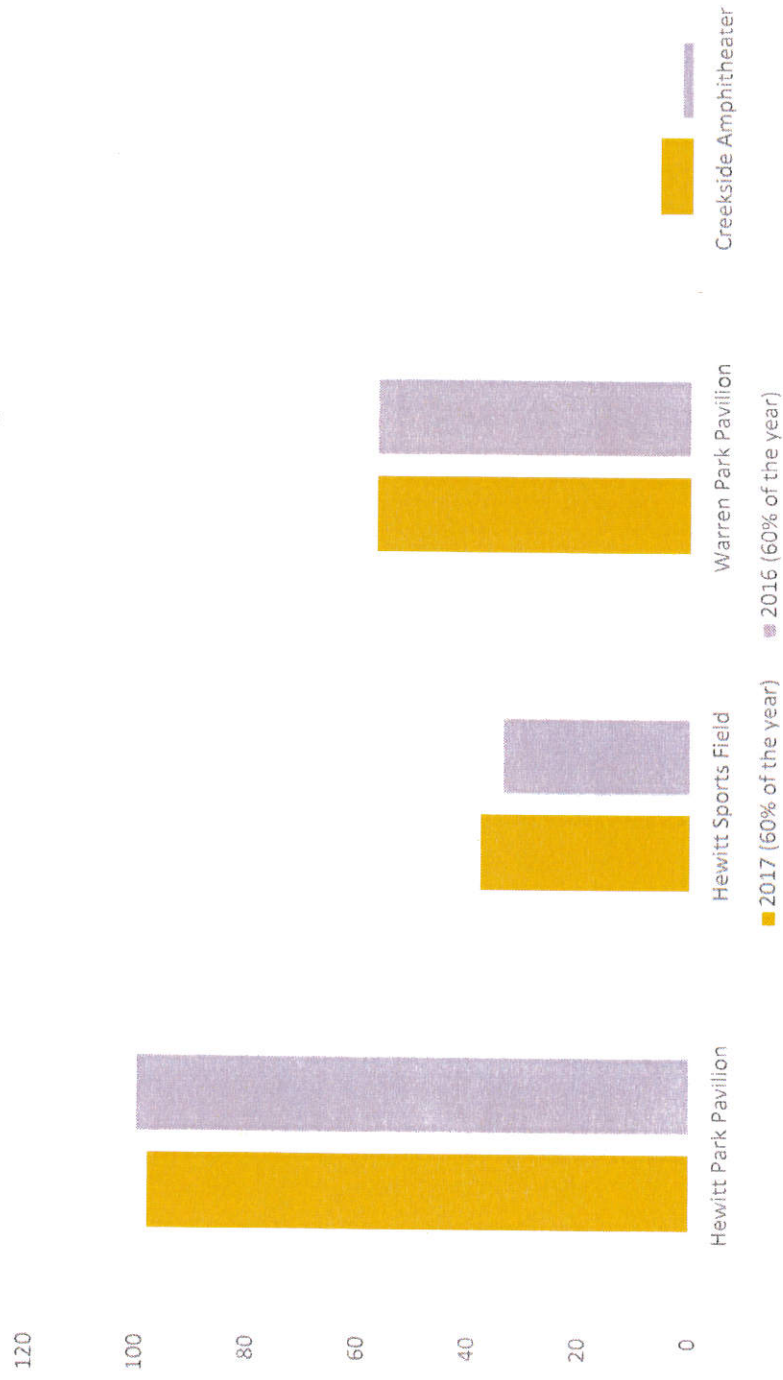
Chart comparing previous years.

City of Hewitt Venue Rentals



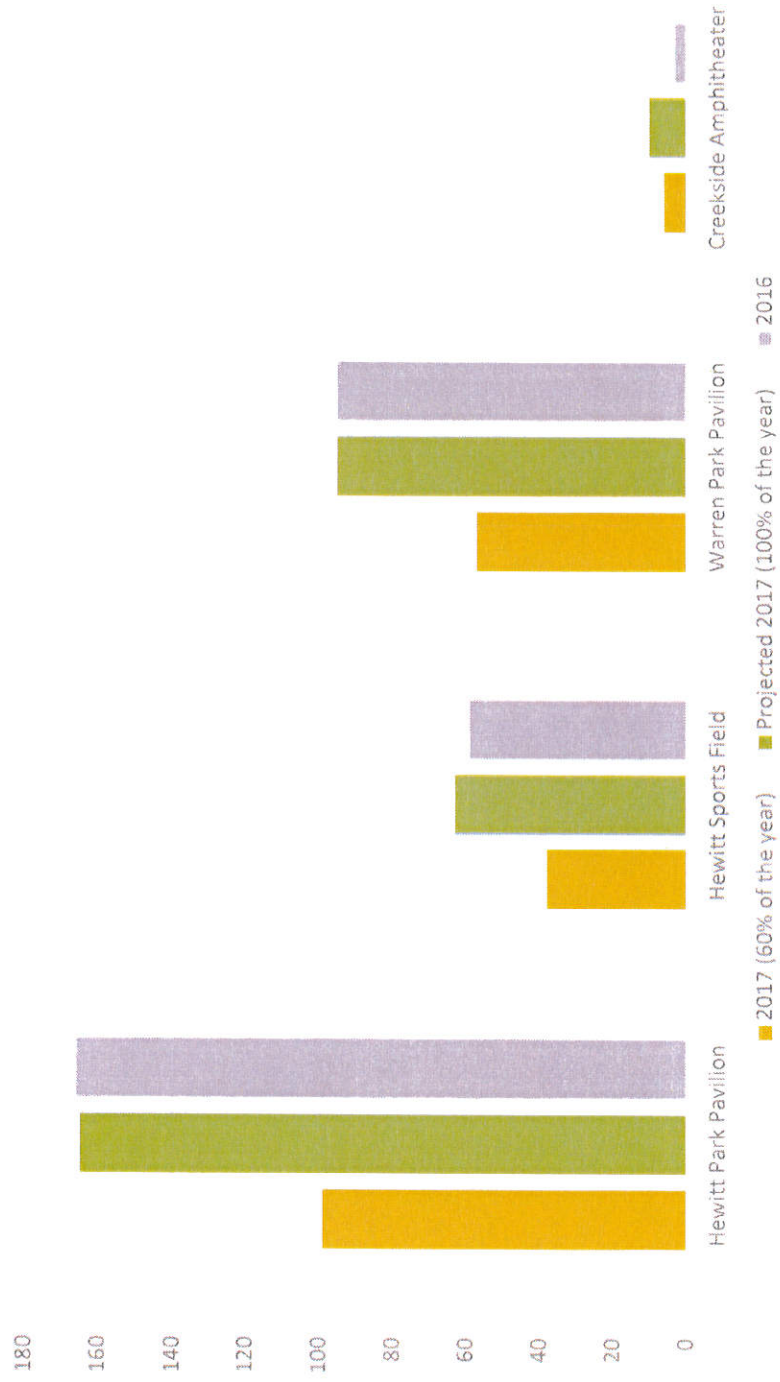
Note: 2017 is only 60% of the year compared to 100% of other years
