 - a. 6:44 PM motioned by Jerry Snider, seconded by Tom Hernandez

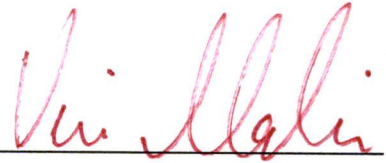
