 - ii. Discussion on having a science class from a local school go to Warren Park to dig, plant, and dedicate a tree

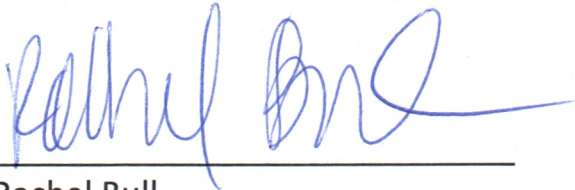
